TOURIST VISA **(foreign citizen resident in the consular circumscription of Bucharest)**

General Information

-**passport** valid at least 3 months after the visa expiration and one copy of all passport pages;

-**residence card** in Romania, original and copy;

-**work** authorization in Romania, if holder of such document;

-**one recent picture** to be attached to the visa application (available free of charge directly at the Visa Office counters), that will have to be filled in correctly in all its parts, in capitals, and will have to bear the applicant's signature;

-**letter of invitation** and the copy of an id of the inviting person or hotel booking;

- copy of the **residence card** (if the inviting person is an extra E.U. citizen resident in Italy);
municipality office registration (if the inviting person is a E.U. citizen resident in Italy);

-**certificates attesting possible family relation** with the inviting person, translated into Italian language and legalized with Apostille (Hague Convention from the 5-th of October 1961);

- demonstration of the availability of sufficient **economic means** (bank statement for the last 3-6 months) for the journey and stay in Italy as predicted by the Table of the Ministry of Internal Affairs Directive from the 1-st of March 2000 or bank guarantee ("polizza fidejussoria") deposited by the inviting person for the foreigner, stipulated with well known banks;

-**round trip ticket or reservation**, in alternative or green card insurance of the car the person intends to travel with;

-**medical insurance** valid for the Schengen territory that has to be covered for the sum not inferior to 30.000 euro, stipulated preferably in Italy (with the National Institute of Insurances – INA) or with a local insurance company;

The applicant will have to demonstrate his/her own social and economic status in order to permit to this Visa Office to value the interest to return to his/her residence country:

- If **employer**:

-Certificate issued by the Commerce Register Office (Certificat constatator) that prove the condition of economic commercial operator + copy;

- Company constitution document + copy;

- Registration Certificate of the company + copy.

- If **employee**:

- Employment book, if holder + copy;

- Employment + copy;

- Holidays granting declaration.

- If **student**:

- Certificate of registration to the corresponding University or College, Record book, Report Card with the exams registration (original and copy).

- If **family related to a E.U. citizen**:

- Birth/Marriage Certificates translated into Italian language, legalized with Apostille (Hague Convention from the 5-th of October 1961).

The application for **minors** of age must be accompanied by the birth certificate of the minor and by the parents authorization to travel abroad translated into Italian language, legalized with Apostille (Hague Convention from the 5-th of October 1961).

The visa could be granted only if all requirements are satisfied. The qualified officers, with the reserve to require additional documents, will take a decision regarding the matter only after verifying in details the application.
