Course Delivery

The Master grants **60 ECTS** and is offered in a **blended format**, combining on-campus sessions with online learning. This approach allows students to benefit from face-to-face interaction whilst enjoying the convenience and accessibility of digital learning.

This master is acknowledged as equivalent to a year of the Master's Degree in Global Politics and International Relations of the University of Parma. Thanks to a partial credit recognition earned during the programme, students can fast-track their academic journey while building on the knowledge and skills already required throughout the master.

Students can thus enroll in MEAP and then continue their university career **within the second year of the Master's Degree in Global Politics and International Relations of the University of Parma.**



Hands-On Learning

A forward-thinking, application-focused programme combining lectures with **interactive exercises, case studies, and project work.**

Develop critical thinking, soft skills, and real-world insights through simulations that mirror daily work in European Institutions and Agencies, preparing you for a successful career.

In addition to the core Modules, the programme includes **advanced English and Italian language courses** (for international students), designed to strengthen communication, interpersonal, and professional skills in multicultural environments.

The programme also includes **Seminars and Workshops** led by academics and practitioners on key European and global challenges, such as European Integration, Artificial Intelligence, and EU political economy.

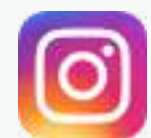
